While speaking to the passenger, the officers noticed he was extremely nervous. Upon being questioned, he admitted to being in possession of marijuana. Officers located the marijuana and a 9MM handgun in his possession. The subject was arrested and also charged with Possession of Marijuana (17 Grams), and Possession of a Concealed Firearm. Both the arrestee and driver admitted to being Latin Kings gang members.

A quick perimeter was established, and Officers made contact with a male matching the description given as he was riding a bicycle through the park. **Update:** During the above listed time, the victim occasionally allowed the suspect to stay at his residence. While at the residence, the suspect stole and fraudulently cashed 5 checks totaling \$1685.00. The victim attempted to draw funds from his personal account and realized that his account was overdrawn. After inquiring at the bank, the victim realized that the suspect had stolen the funds by cashing the checks. A report was completed for the victim on May 20<sup>th</sup> and necessary evidence was collected. On May 21<sup>st</sup>, the suspect reappeared at the victim's apartment, but left prior to CPD's arrival. Patrol units were able to track the suspect down to his girlfriend's apartment in the same complex and take him into custody. The suspect was interviewed by detectives and made a full confession.
