## CLEARWATER POLICE INVESTIGATING CONVENIENCE STORE ROBBERY

**WHO:** Suspect #1: Black Male  
Age: 18-25 years  
Approx. Height: 6'0"  
Approx. Weight 180 lbs.  
Hair: Short cropped afro  
Tattoos: 2 tear drops under left eye  
LSW: black baseball cap, long-sleeve black shirt with white t-shirt overtop (white t-shirt had black design on it), dark jeans

Suspect #2: Black Male  
Age: 18-25 years  
Approx. Height: 5'7"  
Approx. Weight: 150 lbs.  
Facial hair: Thick full beard  
LSW: Doo rag, silver mask (on head, not face), all black clothing

**WHAT:** Armed Robbery

**WHEN:** October 30, 2009

**WHERE:** 7-Eleven

**WHY:** The two suspects entered 7-Eleven and approached the clerk. Suspect #1 requested to purchase a cigar and pulled out money to pay for it.
